1. **CALL TO ORDER** - A meeting of the Energy Improvement District Board was called to order by Chairman Jeffrey Boulrice at 6:32 pm. Members also present: Elizabeth Landry and Jason Ellis. Members not present: Elmar Alikhanov and Tom Aitkin. Staff present: liaison Steve Boske, of the WPCA and recording secretary Leslie Campolongo.

Mr. Boulrice recommended reordering the Agenda to permit Eversource's *Clean Energy Communities* Presentation to occur prior to any pending Board discussion. Motion carried unanimously.

2. **PRESENTATIONS** - *Clean Energies Communities*, Ms. Alison Jackman  
Ms. Jackman presented background on the *Clean Energies Communities* program and the *ICF Energy Benchmarking with Portfolio Manager* (Municipal Technical Assistance program.) Discussion took place regarding Vernon's membership, eligible activities to earn points, the towns current point accumulation and uses of Bright Ideas grant funding to conduct benchmarking.

Further discussion took place regarding data gathering, current energy consumption of high usage buildings. Mr. Boulrice inquired if the "intern" data-inputting program was available for municipalities. Ms. Jackman confirmed the program had been reinstated. Ms. Jackman indicated Benchmarking can begin immediately.

Ms. Jackman also informed the board that advertising regarding the *Clean Energies Communities* program is free to the town, including outreach events.

Discussion took place regarding completing membership of the "Green Team".

Motion made by Chairman Boulrice to "*recommend Municipal Technical Assistance documents be completed for participation in the Clean Energies Communities program.*"

Motion seconded by Mr. Ellis. Motion carried unanimously.

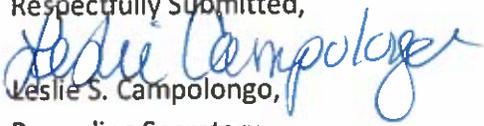
Mr. Boulrice requested the following be placed on next meeting Agenda:
