Minutes – Regular Meeting – December 13, 2012

- 1.0 Chairman Hurd called the meeting to order at 7:32 PM at the Vernon Historical Society. Members present were Hurd, Saucier, Iacobello and Nelson. Arriving during Old Business discussion was Quinn. Also present was Shaun Gately, Vernon Economic Development Coordinator.
- 2.0 Approval of Minutes
 - 2.1 Minutes of the Regular Meeting, November 8, 2012 – A motion was made by Saucier and seconded by Iacobello to approve the minutes of the November 8, 2012 regular meeting. The motion was approved with Hurd, Nelson and Saucier and Iacobello voting in the affirmative.
- 3.0 Communications
 - 3.1 Email correspondence was sent to area legislators regarding the Governor's proposed 25% cut of available funds to the Community Preservation Act.
- 4.0 Review of the PZC, ZBA, and Demolition Applications
 - 4.1 No applications have been received
- 5.0 Unfinished Business
 - 5.1 Design Guidelines for Historic Districts and Properties – Funding procedures appears to be a problem with the town administration. Chairman Hurd will try to resolve the problem.
 - 5.2 Study of the Strong Farm, War Memorial Tower and Hockanum Company House – No further progress has been made. Information on the Strong Farm barn is being submitted for a state study.
- 6.0 New Business
 - 6.1 Schedule of Meetings for 2013 – a motion was made by Quinn, seconded by Iacobello to establish the schedule of meetings for 2013 as the second Thursday of each month at 7:30 p.m. at the Vernon Historical Society aka Grange Hall.
 - 6.2 Other New Business – a brief discussion on the Talcottville Main Street Project. Responsibility for the street lamps timing and bulb replacement was questioned. The Historic Talcottville Association has concerns regarding the responsibility for the garden upkeep. This will be put on a future agenda for further discussion.
- 7.0 There being no further business the meeting was adjourned at 8:05 PM.
