1. Call to Order and Roll Call

Chairperson Lynda Morhardt called the meeting to order at 7:17 p.m. Also in attendance were Ronald Kane and Jeffrey Pescosolido. Staff members present were Marina Rodriguez, Town Planner, and Craig Perry, Town Wetlands Agent.

3. Public Hearing/Action

3.1 Application [IWC-2016-02] of Town of Vernon Engineering Dept. for a wetlands permit to construct a Foot Bridge at the Hockanum River Linear Park at Windsorville Road (Assessor's ID: Map #07, Block #RROW, Lot/Parcel #0000).

Town Planner read into the record the Public Notice published in the *Journal Inquirer* on August 13, 2016, and August 20, 2016. Same Notice was also sent to the Town of Ellington on August 2, 2016, and the abutters on August 8, 2016.

Town Planner also added to the record that Commission received Staff Comment Sheets from Fire Marshal dated July 22, 2016, Zoning

foundation removal, proposed new construction, stone wall along lake, drainage systems, run off to infiltration underground leaching trench. Also discussed was run-off from Grier Road, connecting with sanitary sewer, additional straw bales, and anticipated long-term life of drainage system. A request was made to look at collection system for the amount of water flow during and after construction. Significant activity was determined and a public hearing will be scheduled at the next Inland Wetlands Commission Meeting on September 27, 2016.

*Mr. Pescosolido made a motion seconded by Chairperson Morhardt that Application [IWC-2016-03] of John Williams & Jo-Anne Rankin for a Wetlands Permit to construct a single-family house at #129 Grier Road (Assessor's ID: Map #52, Block #0140, Lot/Parcel #00027) is a significant activity due to the existing grading and contours of the property, the proposed activity, concern that protection devices are present during construction as it is an abutting parcel to the lake, and to schedule a Public Hearing at the next scheduled IWC meeting, September 27, 2016. Motion carried unanimously.*

Mr. Perry, Town Wetlands Agent, distributed the IWC Project Status Report for August 2016 and discussed the status of the Applications.
