The balanced budget proposes no per capita increase over the present year. The per capita local share amount will remain at \$4.67. Naturally each town's contribution will be based on the population which has increased or decreased at different rates in each of the towns; therefore, making individual town's increase or decrease vary accordingly. The District as a whole has seen a decrease in population of 774.

No one spoke in favor or against the proposed budget.

Vic Mathieu made a motion, seconded by Mary Ann Turner, to adjourn the Public Hearing. The public hearing on the proposed 2017-2018 budget was closed at 7:05 p.m.
