3. Public Hearings and Action on Applications

3.1 Application (PZ-2015-09) of Talcottville Development Co. LLC for a Resubdivision into 2 lots at #57 & #163 Hartford Tpke (Assessor's ID: Map #1, Block #158, Lot/Parcel #00057 & #00163).
