3.1 Application (PZ-2016-07) of Matt Walsh (Starbucks) for a Special Permit to construct an Electronic Message Board Sign at #135 Talcottville Road (Assessor’s ID: Map #02, Block #04, Lot/Parcel #078A)

- Chairman Charles Bardes opened the Public Hearing at 7:35pm.
- Town Planner Marina Rodriguez read the Public Notice into record.
- The following Town and Staff comments were received:
