PROPOSED RESOLUTION:

WHEREAS, The Capitol Region Council of Governments (CRCOG) issued on February 14th, 2013 a Request for Proposals (RFP) for the "Reconstruction of Elm Street and Ellington Avenue", and

WHEREAS, the funding source for the roadway construction is through the STP-URBAN PROGRAM with a limit of \$1,000,000 per project which includes 80% Federal Participation, 10% state participation and 10% Municipal Participation; and

WHEREAS, in response to CRCOG'S RFP the Town has prepared and will submit an application for funding the construction of the "Reconstruction of Elm Street and Ellington Avenue", and

WHEREAS, the application will be submitted to CRCOG on Wednesday, July 17th, 2013 in the amount of \$2,274,011 which includes all costs associated with the construction of the roadways; and

WHEREAS, the design of the roads will be performed by a consultant; and

WHEREAS, the Vernon Town Council, based on the above information, and by virtue of this resolution, hereby fully supports the proposed project.

4. **Request the Town Council authorize Mayor George F. Apel to submit an application on behalf of the Board of Education to the State of Connecticut Homeland Security School Competitive Grant Program. Further, it is requested that he be authorized to execute any and all documents necessary for same.** (See letter from Dr. Mary P. Conway, Superintendent of School to Mayor George F.
