Presentation to the Town Council by Mayor Daniel A. Champagne on various topics.

- There is a lot of activity around town, including the replacement of the building façade at Citizen Block-construction should be complete by mid-September; several buildings are being taken down at the Amerbelle Campus-Brooklyn Street will be closed to traffic during the work period; and new roofs are being placed on Skinner Road School, Northeast School and VCMS-construction will be complete prior to the start of the new school year
- Parks and Recreation camps are going strong with over 340 campers per week participating at Newhoca, Valley Falls, Henry Park, Center 375 and Kiddie Camp.
- As of last Friday, 2,155 lunches were served to children 18 and under between Henry Park, Talcott Park and Park West.
- The fireworks were a huge success, with the “fun zone” at Henry Park and games and food in the center of town.
- The Fitness Trail at Dart Hill Park is fully functional. Thank you to the Shea and Lalancette families for their very generous donation.
- The Council Chambers upgrade is about to begin. All evening meetings have been relocated to other locations. As of now, the August Town Council Meeting will remain in the Council Chambers.
- The Town of Vernon has maintained its excellent rating of Aa-2 by Moody’s, primarily due to conservative budgeting.
- The Summer Carnival will run Wednesday through Saturday this week, July 20 – July 23.


