1. Mayoral Proclamation Proclaiming April, 2011 - "Fair Housing Month". Peter Olson read a letter from Jeff Arn, Executive Director of the Vernon Housing Authority.

2. Presentation to the Town Council by Mayor Jason L. McCoy on a variety of topics.
 - Approximately 1,000 people attended the Health Fest in town.
 - The kindergarten construction contract for the Arts Center has been awarded to A. Secondo and Son.
 - In two weeks, the blighted properties on High Street and McLean Street will begin being demolished.
 - Interviews have begun for Pete Hobbs' position, building official, as he is retiring.
 - The appellate court has ruled in favor of the Town of Vernon with regard to Home Depot at Exit 67.
 - Bids are coming in for the animal control crematory.
 - In data processing, the Munis upgrade will be complete on April 8, 2011.
 - GEOTMS was upgraded on March 25, 2011. It is ready for the web application.
 - Hatch Hill Road – we will be able to put the project out to bid in approximately 3 weeks.
 - Prospect Street, Phase III, was advertised on March 22, 2011; bids open on April 14, 2011.
 - Ellington Avenue – subject of CDGB, public hearing set for May 3, 2011.
 - Phoenix Street – construction project has been advertised, bids opened and project to start on June 1, 2011.
 - Finance – successful sales; “A” bond rating.
 - If federal government has a shut down, it shouldn't affect our municipality.
 - FEMA – meeting scheduled for April 7, 2011 for reimbursement of January 11, 2011 snow removal cost.
 - DPW received an award from DEP for snow blowers, lawnmowers, etc. They implemented an automatic work order system.
 - Senior Center – on Saturday, April 30, 2011, they will be hosting a luncheon and dance; computer classes offered April 18, 2011.
 - Social Services – currently accepting camp discount applications.
 - WPCA – there are changes in State law regarding grease catcher issues.
 - Board of Assessment Appeals – elderly applications for tax freeze being accepted until May 15, 2011; certified letters have been mailed out for prior year applicants.
 - On March 21, 2011 the Town of Vernon hosted the Tolland Chamber of Commerce “business after hours” on the third floor. Over 50 business professionals, including Congressman Courtney, attended.

Council Member Herbst requested that the Council be provided information and status regarding issues with the Town prior to newspaper publication.

Council Member Krupienski asked for the amount received from CIRMA from equity distribution this year.
