Edie Chernack, 50 Cubles Dr. – Thanked Mayor McCoy for recognizing the importance of eradicating the weed infestation in Bolton Lake. Spoke about the storm drainage system to be installed in the Bolton Lakes area. They have problems with ice and flooding of the roads. Provided a hand-out to members of the Town Council.

Fay Risley, 29 Anchorage Rd. – Requested a portion of the funding to fix roads be directed to the Bolton Lakes Region. Traffic heavy during use of Camp NewHoca

Open Public Hearing (7:20 PM)

Mayor McCoy called the public hearing to order to receive comments and answer any questions from the public. The clerk read the legal notice into the record.

Public comments:

Sigurd Folstad, 39 Deerfield Dr. – Requested TC members drive through the area of Trout Stream, Tumblebrook and Clothespin Drive. He provided pictures of the roads that include missing curbs, cracks and chunks taken out of the road.

Ray Nelson, 46 Quarry Dr. – Requested Council Members consider adding Quarry Drive to the Merline Drive repairs or take it into consideration for the next set of road repairs.

September 7, 2010

Sue Perry, 26 Ema Lane – Is in favor of the resolution and was informed by DPW that Emma Dr. would be added to the list of roads to be repaired. Requested a motion be made to make it official.

Public Works Director Kleinhans gave a presentation that included road repairs completed to date and future repairs.

John Murray, 19 Hany Lane – Requested Town Council members set up a mechanism to fund capitol improvements that includes a regular maintenance schedule for the roads and can't be touched every budget season.

Edie Chernack, 50 Cubles Dr. – Saw Cubles Drive on the list of roads in the presentation that received shims and has not seen the repair to date. She also mentioned the need for storm drains.

Jean Asherman, Edith Road – Encouraged passage of the resolution.

Richard Wurst, Donnel Road – Encouraged passage of the resolution.

Mary Proulx, 32 Wellwood Circle – Encouraged support of the resolution.

Bill Smith, Vernwood Dr. – Concerned about the closing of Oviat Rd because the businesses need it.

Don Bellingham, 64 Gerald Dr. – Encouraged support of the resolution.

Vince Lamaris, 12 Wolcott La. – Their roads were down to dirt, but they were temporarily repaired. As members of the Town Council consider road repairs, they also need to consider that the worn roads may reduce the value of the citizen's properties.

RESOLUTION REGARDING AN ADDITIONAL APPROPRIATION FOR ROADWAY IMPROVEMENTS IN THE AMOUNT OF \$800,000.00

WHEREAS, in a continuing effort to improve the roadways in the Town of Vernon and as a complement to the current public bond improvement program, the Department of Public Works has identified roads to repair, reclaim shim, chip and micro-pave, categorized as Groups # I and # II – Skinner Road area; and Groups # III and # IV – Merline Road area.

WHEREAS, Group # I consists of the roads: Barbara Road; Neil Road; Gerald Drive; John; Hany; Edith; and Donnel. The estimated cost for this group of roads is \$340,560.00.

WHEREAS, Group # II consists of the roads: Wellwood Circle; Lawler; Hayes; Werner; Wolcott; George; Faith; Olive; Brimwood; Leona; and Bruce. The estimated cost for this group of roads is \$138,012.00.

WHEREAS, Group # III consists of the roads: Discovery, Duncaster; Wilshire; and Seneca. The estimated cost for this group of roads is \$219,120.00.

WHEREAS, Group # IV consists of the roads: Crest; Patricia; Claire; Forestview; Castlewood; Marjorie; Vernwood; Howard Oakmoor; Vinetta; and Walker Terrace. The estimated cost for this group of roads is \$176,958.00.

WHEREAS, pricing may fluctuate due to conditions and the economy, a ten percent contingency of \$87,465.00 is included in the total estimated cost.

WHEREAS, the estimated costs of this project is \$962,115.00, and is to be included in the six-year capital improvement plan. The funding of \$800,000.00 is recommended to come from undesignated fund balance, as of June 30, 2010. The balance of the estimated cost, \$162,115.00, is to be derived from grants and other designated sources. If a funding shortfall occurs, the project appropriation will be restricted to available funds, and the road projects will be adjusted accordingly. Work on any of the identified road projects may only commence when funding for that portion of the project is fully designated in relation to the estimated cost.




