VERNON - State Project 0171-0394 will upgrade the pedestrian control features at the intersection of Route 74 at Park Street, Park Place and St. Bernard Terrace, which may include the installation of countdown pedestrian signal heads, new sidewalk ramps and sidewalk extensions that meet the latest Federal Guidelines. It should be noted that the west leg of the intersection abuts Central Park, a Town property. However, impacts to the park will be minimal (de minimis) in nature as the aforementioned pedestrian upgrades at the intersection will be constructed in proximity to the existing pedestrian appurtenance locations.

An easement is required from the Town for the Park property which will encompass only the area necessary for the sidewalk and sidewalk ramp reconstruction and installation of pedestrian signal equipment. A temporary easement is also required on the Park property for the removal of the existing span pole. These activities will not adversely affect any of the features of the park. The impacts to the park will be limited to minor ground disturbance which will be in proximity to the existing pedestrian appurtenance locations. It is anticipated that Central Park will remain open during the period of reconstruction.


