1. CALL TO ORDER & ROLL CALL

The meeting was called to order at 7:08 p.m. by Scott Wieting.

2. ADMINISTRATIVE ACTIONS

A. Acceptance of Minutes of August 17, 2009

C. Application related Correspondences: IWC and PZC applications

- **IWC-2009-04** 60 South Frontage Ticket Network – Public Hearing continued at the September 22, 2009 IWC meeting.

- **IWC-2009-07** #53 Hartford Turnpike – Permit in a regulated area to construct a hotel. A Public Hearing will be scheduled at the meeting of the IWC.

Silt fencing failed and material washed down to brook as the soil was piled 5 ft against fencing.
Craig Perry, Wetlands Enforcement Officer issued a Cease & Correct Order.
The owners were directed to bring the fill to the proposed elevation by removing excess fill and replace the existing silt fence with new fencing and include hay bales. A fine would have been issued if work was not complete in 5 days.
All work had been done as instructed.
Thomas Ouellette observed sand bars in the stream that appear to be consisting of the fill used on the property. He will email the town to question the sand bars down stream but feels a technical analysis must be done before discussion.

D. Letters sent by the Conservation Commission last month

IWC-2009-03 Wetlands Permit letter dated August 21, 2009 sent to IWC.

3. MATURE TREES

This has been approved by the PZC and will be taken off the agenda.

The Commission was concerned that it was too much for the property owner to mark all the trees 18 inches or greater. Len Tundermann, Town Planner, proposed a provision to remove the burden and to simplify the process.

4. NATURAL RESOURCE INVENTORY FOR '09 PLAN OF CONSERVATION AND DEVELOPMENT

Plaimetrics is expected to begin in October.

Scott will send a link of surrounding towns POCD to the Commission for review.

5. BOLTON LAKES ERT – POSTPONED

Budget had been passed and there should be a hearing on the fall schedule soon.

11. OTHER GOALS


