F) PRESENTATIONS BY THE ADMINISTRATION

Robert Grasis, Director of the Water Pollution Control Authority and Ray Weaver, Chairman of the Water Pollution Control Authority updated the Town Council on the Water Pollution Control Facility Upgrade progress.

Mayor Daniel A. Champange made the following presentation to the Town Council:

- 1. JULY IN THE SKY, was a huge success this year. All reports indicate that everyone had a wonderful time and Parks and Recreation put on a wonderful show of activities and of course the awesome fireworks display. Thank you to all those who worked and especially all the volunteers for the evening.
- 2. The combined efforts of our Town of Vernon and Board of Education staff in conjunction with our Health and Safety Committees and the Risk Management Committee, I am pleased to inform you that we received a Member Equity check in the amount of \$30,950 from CIRMA for FY 2017-2018. The Town and BOE earned this rebate because of outstanding results from our Risk Management Program and our general liability experience.
- 3. In the agenda this evening, you will find a budget amendment for the upcoming scheduled Primary events. Election season is upon us and our Registrars will be hard a work from now until November.
- 4. Also in your agenda this evening, is a request to schedule a public hearing relative to the Community Development Block Grant available through the Department of Housing for those homeowners impacted by Crumbling Concrete. This Public Hearing will be held, and our application submitted, on behalf of Ellington, Stafford and Vernon. Please pass the word to those impacted to come and testify at the hearing.
- 5. Vernon ROCKS Coalition is requesting assistance in getting the word out to our families for the summer lunch program. Locations in Vernon are Talcott Park, 70 Elm Street; Henry Park, South Street; and Park West Apartments, 178 Terrance Drive all at 11:45 AM 12:30 PM for more information please call Vernon Youth Services at 860-870-3555.
- 6. The Town of Vernon Emergency Management Team, including CERT and BOE staff, conducted a regional shelter review with the American Red Cross this month at VCMS.
- 7. The Summer Days Carnival is just around the corner. This year's event is scheduled for July 25-28 at the old Golf Land Complex, Route 83. Please come and enjoy the fun. For more information contact the Parks and Recreation Department at 860-870-352.
- 8. I would like to take a moment to thank the Public Works Department for their outstanding work in the Social Service Department on the renovation of the offices. The ability to complete the project in-house provided a tremendous savings and an opportunity to showcase the talents of the department.
- 9. The Social Service Department and Senior Center are working in conjunction with the Connecticut Department of Agriculture to participate in a Senior Farmer's Market Nutrition Program. The Town of Vernon has a submitted a request for vouchers that will be distributed to senior citizens to use at all local Farmer's Markets. This program will connect our seniors with healthy food options at no cost to them or the Town of

Vernon. It's a true win - win.

- 10. This Friday, July 20, 2018, at 10:00 AM there will be a ceremonial signing of the New Senior Center By-Laws at the new Senior Center located at 135 Bolton Road. All are welcome. On behalf of all our senior citizens, I would like to extend a special thank you to the Town Council for all your consideration of this project and ultimately your support.
- 11. In an effort to continually improve our services, Administration and the Finance Department have been working together to improve efficiency relative to our vendor payment processing procedures. Our initial goal has been achieved, and our vendor requisitions are being paid at net 30 days or better. Thank you to all those involved for their continued efforts in this regard. More exciting updates to follow as we evaluate and improve our business processes.
- 12. Finally, I would like to thank the Town Council for their continued efforts relative to the Rockville Public Library and the many changes occurring on behalf of all our residents. On July 2, 2018, a ceremonial signing took place at the library to continue our forward progress. I believe that without the hard work of the committee and Town Council Members Brian Motola, Ann Letendre and Julie Clay would have taken far longer to complete. In addition, the continued support and hard work of this entire Council has provided a strong foundation on which to continue providing library services to our entire community.
