INTERMENTS page 3

1. Cemeteries are open for interments from 8:00 a.m. until 3:00 2:30 p.m. daily. Funerals must vacate the premises by 3:00 2:30 p.m. weekdays to allow for the completion of the burial. Overtime charges will apply beginning at 3:00 2:30 p.m. weekdays with a one-hour minimum charge. There are no interments on Sundays, Memorial Day, Thanksgiving and Christmas holidays or Town of Vernon observed holidays. Additional fees will be charged for Saturday, holiday and after hour interments with overtime charges after 12:30 p.m. Thirty-six hour notice must be given for all interments. Monday interments must be ordered by 10:00 a.m. on Fridays.

3. The cemetery shall not be liable for any floral piece, basket or other containers. All winter decorations must be removed by April 1st (Feb 1st or Mar 1st) of each year. Decorations not removed will be discarded. Unsightly or hazardous items will be removed at the determination of the superintendent.
