# F.) PRESENTATIONS BY THE ADMINISTRATION

Mayor Daniel A. Champagne made a presentation to the Town Council on various topics.

- Thanked Deputy Mayor Steve Wakefield for standing in while he was on vacation.
- National Night Out was held and well attended. Council Member Tom DiDio reported that the event was well attended and approximately 300 packets were given to school children. Over 35 organizations participated in the event.
- Mayor Champagne spoke on Rep. Winkler's comments made during the first public hearing.
- Shakespeare in the Park was held in the back parking area of the Library with the second
  performance inside the Library due to weather conditions. Both events were very
  successful and further supported the community's interest in the Arts in Vernon. Over 138
  people attended the performances. A crowd funding campaign raised a total of \$15,000
  from generous donors and a match from Sustainable Connecticut. Thank you to
  everyone involved.

- As part of our Sustainable CT Recertification, the Town has begun the process of benchmarking its energy consumption in Town Buildings in partnership with Vernon Public Schools, the Energy Improvement District Board, UCONN, Finance, Administration, Water Pollution Control Authority and Public Works. More information to follow.
- Phase I Windermere Fields Project Public Works is removing the topsoil from one of the fields with the new bulldozer. The next step is meeting with Engineering to begin the field design plans. We plan on having a ceremony with Town Council and community stakeholders in the near future.
- Rockville High School Track and Field the new field is complete and a new rubber surface is being applied to the track. Fencing around the field and track has been installed. More information on a ribbon cutting with the Board of Education and the Town Council is forthcoming.
- Citizen Block a close eye is on building material pricing, which appear to be coming down, possibly allowing work to resume sooner than later.
- The sinkhole issue at the dog park has been resolved and repaired; the park has been fully re-opened.
- Information about the distribution of American Rescue Funds is forthcoming. Presently, we are working with local non-profits to identify needs, and will bring forward recommendations to the Council.
- The next Vernon Voice magazine will be published mid-November. This edition will include articles from the Vernon Volunteer Collaborative and updates on ongoing projects around town.
- An Eagle Scout Court of Honor ceremony at the American Legion Post 14, West Road, Vernon was held on August 15, 2021 for Curtis Roggi, who assisted the RHS Music Department Staff in cataloging and organizing decades of sheet music and Zachary Larson, who refurbished, repaired and painted picnic tables for the American Legion members to use during their events. Thank you and congratulations to both Eagle Scouts.
- The Rockville Elks donated \$5,000 to the Social Services Department back-to-school program this year to purchase clothing and school supplies. For nearly 20 years, the community has generously contributed to this program to assist Vernon families. In addition, donations of \$3,500.00 from the community and \$1,000.00 from the Salvation Army were received. Thank you to all who donated.
