
PZ-2020-03 209 South St.








The Chairman and I met on February 25, 2020 to discuss a wide menu of challenges and opportunities facing the Conservation Commission.

As a reminder, the CGS sets forth the roles and responsibilities of a Conservation Commission:

- Shall research and consider the utilization of land area;
- May propose Greenway Planning;
- Shall keep and index of all open spaces;
- May inventory natural resources and watershed management plans;
- May provide recommendations to the PZC and IWC on relevant application matters:

We identified two primary goals: 1) Protection of open spaces and 2) Increase public education on conservation matters. This is a good starting point.

Among other menu items the Commission has considered recently:

- Public education forums/series on multiple topics
 - Conservation principles
 - o Road Salt
 - Recycling
 - Vernal Pools
- Implementation of applicable Sustainable CT conservation-related items
- Implementation of Tankerhoosen and other Greenways
- Labeling of infrastructure outfalls
- Coordination with Open Space Task Force
