## IV. Program Updates

Shelley McCone provided an update for VPS on the below topics.

## A. Accreditation update

Shelley reported that teachers have been preparing for an accreditation visit, including preparation of their classroom portfolios and that she has been preparing the administrative portfolio. A visit should be scheduled within the next

month, some time before ThanksGiving.

#### B. Program Enrollment

The 32-half day, part time school readiness slots located at Vernon Public Schools are currently fully enrolled

### C. Challenges and Need

Shelley shared that there may be a need to combine 3 and 4 year old's, because there are a growing number of 3 year old's that have been identified as eligible for preschool services.

A walk-through exercise showed large opportunities to strengthen and update Youth Services and School Readiness websites
